PARK IS OPEN FROM 7:00 A.M. UNTIL DUSK.

DEFACING, DESTROYING OR REMOVING ANY SIGN, POSTER, BUILDING, TREE OR OTHER PROPERTY IS PROHIBITED.

FIRES PERMITTED ONLY IN GRILLS.

INTOXICATION, INDECENT LANGUAGE, UNNECESSARY NOISE OR ANY OTHER ACTS OFFENSIVE TO THE PUBLIC ARE PROHIBITED.

LITTERING OR DEPOSITING REFUSE OR RUBBISH ON PARK PROPERTY IS PROHIBITED. ALL REFUSE MUST BE PLACED IN DESIGNATED RECEPTACLES.. ALL BAGS OR TRASH MUST BE PLACED IN THE DUMPSTER.

NO COMMERCIAL ACTIVITY IS PERMITTED WITHOUT A PERMIT ISSUED BY THE BOROUGH MANAGER.

THESE RULES AND REGULATIONS ARE MADE PURSUANT TO THE AUTHORITY GRANTED BY ORDINANCE NO. 517 ENACTED BY THE OXFORD BOROUGH COUNCIL AND VIOLATION OF SUCH RULE SHALL SUBJECT THE OFFENDER TO THE PENALTY SET FORTH IN SAID ORDINANCE.

RESOLUTION #1076-2005

A RESOLUTION FOR ESTABLISHING GUIDELINES AND
FOR USE OF THE OXFORD MEMORIAL PARK

BE IT RESOLVED by authority of the Borough Council, Borough of Oxford,
Chester County, Pennsylvania, that:

Park facilities may be reserved on a first-come, first-served basis.

A reservation form must be completed and submitted to the Borough Office.

A non-refundable fee of \$40.00 will be required for the use of the Park (including pavilion).

A \$100.00 trash and damage deposit will be required for organizations or groups of over fifty (50) people and will be refunded as long as the Park is cleaned and trash removed. If trash is not removed, a fee will be deducted from the deposit.

Each group reserving the Park will receive a copy of the Rules and Regulations.

Placement of "Reserved" signs on the pavilion will be the responsibility of the Borough.
